০২। শিক্ষার্থীরা ব্রাজিলের কেন্দ্রীয় স্বাস্থ্য ব্যবস্থায় বিনামূল্যে চিকিৎসা সুবিধা প্রাপ্য হবেন। ১৮ বছরের উপরে যে কোন বাংলাদেশি নাগরিক (মাধ্যমিক ও সমপর্যায়ে ন্যূনতম শতকরা ৬০ ভাগ নম্বরের অধিকারী) উক্ত মেধা বৃত্তির জন্য আবেদনের যোগ্য বিবেচিত হবেন। স্নাতক পর্যায়ের শিক্ষার্থীদের জন্য চলমান বছরে আবেদনের সময়সীমা জুন/জুলাই ২০২৪ পর্যন্ত হওয়ায় অধিকতর তথ্যের জন্য dce@itamaraty.gov.br-এ ইমেইলে যোগাযোগ করা যেতে পারে। উল্লেখ্য, ব্রাজিল সরকার থেকে এবারই প্রথম বাংলাদেশি শিক্ষার্থীদের জন্য মেধাবৃত্তি কোটা সংরক্ষণ করা হয়েছে এবং মেধাবৃত্তির ব্যাপারে বাংলাদেশি শিক্ষার্থীদের প্রাধান্য দেবার ব্যাপারে সিদ্ধান্ত নেওয়া হয়েছে। বাংলাদেশ থেকে উক্ত মেধাবৃত্তি প্রাপ্তির জন্য কোন আবেদনপত্র প্রেরিত না হলে ভবিষ্যতে ব্রাজিল সরকার এ মেধাবৃত্তি চলমান রাখার ব্যাপারে নেতিবাচক ধারণা পোষণ করতে পারেন।

The Embassy of the Federative Republic of Brazil presents its compliments to the Ministry of Foreign Affairs, South America Wing, and Government of the People's Republic of Bangladesh and has the honour to reiterate hereby the invitation to include Bangladesh in the Student Agreement Program (PEC), made on the occasion of the Brazilian Minister of External Relations, Ambassador Mauro Vieira's visit to Bangladesh in 7-8 April 2024. There follows information about the Program.

i) PEC-G (GRADUATION) and PEC-PL (PORTUGUESE AS A FOREIGN LANGUAGE)

Officially created in 1965, the Program Students-Graduation Agreement (PEC-G) offers free vacancies in graduate courses at more than one hundred Brazilian institutions, Universities and public institutions as well as higher education in private institutions. The program is jointly administered by the Ministry of External Relations (MRE) and the Ministry of Education (MEC), in coordination with the above mentioned institutions.

Registration for the PEC-G is annual and is scheduled to take place between June and July. If Bangladesh decides to join, applications can be sent to Brasilia as soon as the Embassy receives notice of the institutions selected for this year's activities. This procedure repeats itself every year. The Embassy will keep the Ministry informed about the next steps concerning 2024.

One of the requirements to join the PEC-G is obtaining the Portuguese Language Proficiency Certificate for Foreigners (Celpe-Bras), administered by the National Institute for Educational Studies and Research Anísio Teixeira. Selected candidates who do not have the Celpe-Bras certificate must carry out, during their first year in Brazil, a Portuguese course for foreigners at one of the public or private institutions part of the program. The period provides an opportunity for academic experience in country, in which cultural contact allows students greater preparation for carrying out graduation

studies. At the end of the Portuguese course, students must take the Celpe-Bras exam. If approved, the candidate will enter graduation (PEC-G) in the following year.

At the end of the course, PEC-G graduates must return to their country of origin and collect their academic documents (diploma, transcript and syllabi) in the station where they registered for the program.

It is noteworthy that the PEC-G, despite granting vacancies and access to Brazilian higher educational institutions, does not offer financial aid, unless in specific cases. Therefore, all students must have financial responsibility to cover their stay throughout period in Brazil, as well as his return to the country of origin. The support from financing sources is permitted and encouraged as is the case of countries like Gabon, which provides monthly scholarships to all its students selected in PEC-G. The Program's new regulations will allow students to carry out remunerated activities in Brazil, as long as it is compatible with their study schedule load.

In case of joining, the Bangladeshi Government will be therefore responsible for supporting students during their stay in Brazil, providing the assistance that may be needed in consular matters, adaptation and maintenance. This dynamics was also informed to the Bangladeshi embassy in Brasilia by Note Verbal.

ii) PEC-PG (POSTGRADUATE)

The Postgraduate Student Agreement Program (PEC-PG), officially created in 1981, offers the foreign student's scholarships for courses "strictu sensu" in postgraduate studies (master's and doctorate). Brazilian members of the PEC-G become automatically members of the PEC-PG.

The PEC-PG is administered in partnership by the Ministry of External Relations (MRE), the Superior Coordination for Personnel Improvement (CAPES), connected to the Ministry of Education (MEC), and by the National Scientific and Technological

Development Council (CNPq), linked to the Ministry of Science, Technology and Innovation (MCTI).


In addition to free places on postgraduate courses, those selected receive a monthly grant in the same amount as that offered to Brazilian students, with a maximum duration of 24 months (in the case of master's degrees) and 48 months (in the case of doctorates), and the return ticket to the country of origin at the end of the course.

The Embassy hopes that this preliminary information may be the beginning of a bilateral partnership in education, which Brazil has been carrying on with many countries, and so enhancing the bilateral ties, person to person contacts, as well as deepening the mutual knowledge between Brazil and its Partners in this program.

The Embassy of Brazil avails itself of this opportunity to reiterate to the Ministry of Foreign Affairs, Government of the People's Republic of Bangladesh, the assurances of its highest consideration.

Mission has received a note verbale from the Ministry of Foreign Affairs of Brazil no. DCE/DIAM/04/KCEE-Bras-Bang dated 20 March 2024 inviting Bangladesh to send students to take part in Brazilian government program named Student-Covenant Program (PEC) which has both undergraduate (PEC-G) and Graduate (PEC-PG) affiliation (copy attached). Mentionable that Bangladesh signed an Agreement on Cultural and Educational Cooperation with Brazil on September 27, 1988 under which the scholarship offers are being considered.

02. The key features of the scholarships are briefly mentioned in the diplomatic note. Unofficial translation of the note verbale and a list of the public and private universities from different states of Brazil are also attached.

03. His Excellency Mauro Vieira, Hon'ble Foreign Minister of Brazil may announce this special opportunity that is being offered for the Bangladeshi undergraduate students during his forthcoming visit on 7-8 April 2024.

04. Ministry is requested to take necessary action in this regard.

05. This issue follows discussion and the kind approval of Her Excellency the Ambassador.

The Ministry of Foreign Affairs presents its compliments to the Embassy of the People's Republic of Bangladesh and has the honour of inviting the country to participate in the Student-Covenant Program (PEC) of the Brazilian Government, in its Undergraduate (PEC-G) and Graduate (PEC-PG) modalities.

2. Participation in the PEC would take place under the Cultural and Educational Cooperation Agreement between the Government of the Federative Republic of Brazil and the Government of the People's Republic of Bangladesh, signed on September 27, 1988.

3. Officially created in 1965, PEC-G offers foreign students free undergraduate places at more than 100 public and private Brazilian Higher Education Institutions (IESs). The list of IESs currently participating in the Program is attached.

In addition to a totally free place, PEC-G students are entitled to free care from Brazil's public health system and free legalization of their academic documents (diploma, transcripts and transcripts), which must be obtained from the Brazilian diplomatic mission in their country.

4. Registration for the PEC-G is annual and usually takes place in June and July. Those interested must submit the documentation required by the public notice to the Brazilian diplomatic mission in their country. When applying, you can indicate up to two-course options and the HEI where you want to study. There is no limit to the number of places per country.

5. The requirements for applying to the PEC-G are as follows:

- be a national and resident of a participating country;
- not have Brazilian nationality or a permanent residence permit in Brazil;
- be at least 18 years old by the date specified in the notice;
- have completed high school (secondary or equivalent) with an overall average of 60% or more;

- prove that they can afford to stay in Brazil for the duration of their studies.

Applicants must have a financial guardian (individual or legal entity) who undertakes to send them monthly funds during their stay in Brazil. Currently, the minimum monthly amount for student maintenance is US\$400.00 (four hundred US dollars); and

- obtain the Certificate of Proficiency in Brazilian Portuguese for Foreigners (Celpe-Bras).

6. Celpe-Bras is the official exam for proficiency in the Brazilian version of the Portuguese language, and is administered by the Anísio Teixeira National Institute for Educational Studies and Research (INEP). In countries where the Celpe-Bras exam is not administered, such as Bangladesh, applications are accepted without the certificate. In this situation, if selected, the student will have to take a course in Portuguese for foreigners at an IES participating in the program during their first year in Brazil, at the end of which they will have to take the Celpe-Bras exam. If successful, they will enter the undergraduate program the following year.

The Embassy of Bangladesh will be asked to waive the fees for legalizing the graduates' academic documents, as well as to accompany the students during their stay in Brazil, providing support on consular, adaptation and maintenance issues. Since the PEC-G students must have a financial sponsor, the Bangladeshi government will be able to verify the possibility of granting scholarships or other benefits to those selected, such as airline tickets.

The PEC-PG, on the other hand, offers scholarships for master's and doctorate courses in all areas of knowledge, as well as exemption from paying fees and tuition at Brazilian HEIs and care through Brazil's public health system. The program is managed by the Ministry of Foreign Affairs in conjunction with the National Council for Scientific and Technological Development (CNPq) and the Coordination for the Improvement of Higher Education Personnel (CAPES), the institutions responsible for paying the scholarships.

The PEC-PG is currently being reformulated, following its interruption during the COVID-19 pandemic. More information on the requirements for participation and the application process will be sent in due course.

O Ministério das Relações Exteriores cumprimenta a Embaixada de Bangladesh e tem a honra de convidar o país a participar do Programa de Estudantes-Convênio (PEC) do Governo brasileiro, em suas modalidades de Graduação (PEC-G) e de Pós-Graduação (PEC-PG).

2. A participação no PEC ocorreria ao amparo do Acordo de Cooperação Cultural e Educacional entre o Governo da República Federativa do Brasil e o Governo da República Popular de Bangladesh, celebrado em 27/09/1988.

3. Criado oficialmente em 1965, o PEC-G oferece a estudantes estrangeiros vagas de graduação gratuitas, em mais de cem Instituições de Ensino Superior (IES) brasileiras, públicas e privadas. A lista de IES atualmente integrantes do Programa segue em anexo.

Além da vaga totalmente sem custo, o estudante PEC-G tem direito a atendimento pelo sistema de saúde pública do Brasil e à legalização gratuita de seus documentos acadêmicos (diploma, histórico escolar e ementas), os quais devem ser retirados na missão diplomática brasileira em seu país.

4. As inscrições para o PEC-G são anuais e ocorrem, normalmente, nos meses de junho e julho. Os interessados devem apresentar a documentação exigida em edital à missão diplomática brasileira em seus países. No momento da inscrição, é possível indicar até duas opções de curso e IES onde estudar. Não há limites de vagas por país.

5. Seguem os requisitos para concorrer ao PEC-G:

- ser nacional e residente de país participante;
- não possuir nacionalidade brasileira ou autorização de residência permanente no Brasil;
- ter no mínimo 18 anos completos até a data especificada em edital;
- ter concluído o Ensino Médio (secundário ou equivalente) com média geral igual ou superior a 60%;

- comprovar meios para manter-se no Brasil durante todo o período de estudos.

Os candidatos devem contar com responsável financeiro (pessoa física ou jurídica) que se comprometa a enviar-lhe recursos mensais durante a estada no Brasil. Atualmente, o valor mensal mínimo para manutenção do estudante é de US\$400.00 (quatrocentos dólares norte-americanos); e

- obter o Certificado de Proficiência em Português Brasileiro para Estrangeiros (Celpe-Bras).

6. O Celpe-Bras é o exame oficial de proficiência na vertente brasileira da língua portuguesa, e é administrado pelo Instituto Nacional de Estudos e Pesquisas Educacionais Anísio Teixeira (INEP). Em países onde o exame para obtenção do Celpe-Bras não é aplicado, como é o caso de Bangladesh, são aceitas candidaturas sem a apresentação do certificado. Nessa situação, caso selecionado, o estudante deverá realizar, ao longo de seu primeiro ano no Brasil, curso de português para estrangeiros em IES participante do Programa, ao fim do qual deverá prestar o Celpe-Bras. Se aprovado, ingressará na graduação no ano seguinte.

7. À Embaixada de Bangladesh será solicitada a isenção de emolumentos para legalização dos documentos acadêmicos dos graduados, bem como o acompanhamento dos estudantes durante sua permanência no Brasil, com prestação de apoio em questões consulares, de adaptação e manutenção. Uma vez que os alunos PEC-G devem contar com responsável financeiro, o Governo bangladês poderá verificar a possibilidade de concessão de bolsas de estudo ou outro benefício aos selecionados, tal como passagens aéreas.

8. O PEC-PG, por sua vez, oferece bolsas de estudo para cursos de mestrado e doutorado em todas as áreas do conhecimento, além de isenção do pagamento de taxas e mensalidades nas IES brasileiras e atendimento pelo sistema de saúde pública do Brasil. O Programa é gerido pelo Ministério das Relações Exteriores em conjunto com o Conselho Nacional de Desenvolvimento Científico e Tecnológico (CNPq) e a Coordenação de Aperfeiçoamento de Pessoal de Nível Superior (CAPES), instituições responsáveis pelo pagamento das bolsas.

9. O PEC-PG se encontra em fase de reformulação, após sua interrupção durante a pandemia de COVID-19. Mais informações sobre os requisitos para participação e

processo de inscrição serão encaminhadas oportunamente.
